Jack made a motion to accept minutes from 10/19/22 and the motion was passed with a clarification to Bill Bane that the \$32,010.00 in allocations on those Minutes is not the total amount of grants, it was the last-minute donations gathered to help with the shortfall in funding.

Bob Mason was welcomed as a new Board Member, replacing John Reock. Ed Leary was welcome as a new Board Member replacing George Reinhart.

Rich Boss gave a Treasurer's update (see attached) and reported that all Conflict of Interest statements have been received.

Lisa McDonald gave a Secretary update (including above clarification to Bill Bane) and reported that the new member orientation documentation was tweaked for use going forward as handouts that can be used when a new member prospect has organizational questions (see attached). Bob Leggett moved to approve the transfer of funds from Operations account to Contributions to fund previously approved Grants. The motion passed unanimously. (see #6 on attached Agenda)

Bill Nelson gave an update on increased rates for dinner at Seabrook Island Club. Jack made a motion to accept \$41/plate rate. Ray Hoover seconded the motion.

Flags for Bohicket Run will be put up the day of, but signs will be put out the night before. Delay in set up of flags is due to potential theft. A new flag (just the flag) is \$24 for American Made. Jack is working with The Town of Kiawah to establish a safe and dry storage space.

- All Conflict of Interest Statements received (except for George Reinhart, who resigned before I filed the 990).
- IRS Form 990, SC Registration, and SC Financial Report (copy of 990) all submitted by November 15 due date. Self prepared. Minor costs of about \$200 for software and SC filing fees.
- Transition / Open
  - Foundation Schwab application submitted October 27 to add Boss and Leggett as signers
- Upcoming Actions
  - Bohicket Run proceeds expected in Q1 2023 (was \$9,000 in 2022)
