The annual award was first presented in 2012 and recognizes a person who performs volunteer services that contribute significantly to the people and/or quality of life of Wadmalaw, Johns, Kiawah, and/or Seabrook Island. The award is named after the historic live oak tree on Johns Island which clearly represents the people, culture, and natural environment of the islands.
