TRIBUTE TO SC FALLEN HERO

Good evening, fellow Exchange Club members and guests,

Tonight, we honor the life and legacy of *Army Sgt. James E. Craig.

From a young age, James stood out—not just for his talents, but for the sheer force of his spirit. At Academic Magnet High School, near Hollywood, South Carolina, he excelled in every arena: top of his class, a gifted musician, a star on the football field and wrestling mat. His father, Joel Craig, described him as a "thrill seeker," recounting with a laugh, "He once flew my dirt bike over the barn roof. I saw the motorcycle flying through the air—with him on it." After graduating in 2000, James enlisted in the U.S. Army and trained at Fort Benning, Georgia. He was later stationed at Fort Wainwright, Alaska, where he became a sniper. When our nation was attacked on September 11, 2001, James didn't hesitate—he requested reassignment to a unit bound for action. He was transferred to the 1st Battalion, 8th Infantry Regiment, 3rd Brigade Combat Team, 4th Infantry Division, Fort Carson, Colorado. Around that time, he met Natalie. It was love at first sight. They married in July 2007. In one treasured photo, he's in his Army dress blues, Infantry blue cord over his shoulder; Natalie, radiant in her white gown, clutches him tightly with pride and joy.

*Just months later, James deployed for his third tour in Iraq. "He loved the Army. He loved what he was doing," his family said. Those who served alongside him tell of a man who never backed down—not in games, not in life, not in duty. If you beat him at something, he'd flash that grin and say, "One more time," or "Best two out of three." He was determined, joyful, endlessly resilient. Whether on a mission in Mosul or playing guitar among friends in Alaska—writing songs with more heart than polish—Sgt. Craig led by example.

On January 28, 2008, while on patrol in Mosul, Iraq, Sgt. James E. Craig's convoy came under attack. Small arms fire and improvised explosive devices destroyed their Humvee. *At just 26 years old, Sgt. James E. Craig gave his life for our freedom—alongside four of his brothers in arms.

But James didn't just serve. He led. He laughed. He loved. And he left behind a legacy not of sorrow, but of strength. He lived by the words: "No Reserves, No Regrets, No Retreats." That wasn't just a motto—it was his creed, his compass, his calling.

As a tribute to Sgt. James E. Craig and all those who have laid down their lives in service, the Exchange Club places American flags around our community several times a year. Each flag bears a yellow ribbon with the name of a South Carolina fallen hero—ensuring their sacrifice is remembered, always.

Army Sgt. James E. Craig—we salute you. We honor your service. We carry your legacy forward. Now, I invite you to please stand, as you are able, and join me in reciting the Pledge of Allegiance.
